Subject: Update on FSUI Meeting with DCIL on Pending Grievances

Dear Brothers,

We are pleased to provide an update on the FSUI meeting held at Dredging Corporation of India Ltd. (DCIL) on 26 September 2025, where long-pending grievances of Petty Officers and Seafarers were discussed in detail.

Key Outcomes from the Meeting:

Job Security: The issue of job security for all Seafarers employed with DCIL since 2006-07 was addressed. Management has agreed to accord the highest priority to this matter and ensure long-term sustainability for all personnel.

Seniority Supplement: Positive assurance was received for extending seniority supplements to batches joined between 2000 and 2007.

Promotions: Our submissions regarding promotions for ETC, DTC, and Chief Cooks were considered favorably. Management has committed to reviewing these with the relevant teams and providing a positive response soon.

Victualling Allowance: DCIL has partially agreed to consider an increase in the victualling allowance.

Other Allowances: Management confirmed that Travelling Allowance, Washing Allowance (for uniforms), Noisy Repair Works Allowance, and Ship Keeping Allowance are being disbursed under the Special Allowance category. We have requested a rank-wise payment slip statement for verification of these claims.

Gratuity and Arrears: While an initial agreement was reached on gratuity payments, a follow-up FSUI delegation met with the Directorate General of Shipping (DG Shipping) on 8 October 2025. We submitted claims for long-pending arrears, non-payment of gratuity by DCIL, enhancement of seniority supplements, and an annual increment of 10% management has assured a positive resolution after consulting the Board members.
